\_\_\_\_\_ I am aware that computers may be used in the classrooms for educational purposes. I give permission for my child to use the classroom computers. I also give permission for my child to watch short movies/TV clips when shown for educational or entertainment purposes.

\_\_\_\_\_ I am aware that the LSKC website, [www.thelittleschool.us](http://www.thelittleschool.us), and the local media (i.e., newspapers, TV, etc.) may contain pictures of school activities and events. No names will be used with the pictures. I give permission for my child to be photographed and for those pictures to be used on the website and in the local media.

\_\_\_\_\_ I am aware that class lists may be shared to help parents in sending birthday invitations or setting up play dates. Information will only be shared with classmates and other LSKC families. I give permission for my name, address and telephone number to be shared.

\_\_\_\_\_ I have read and understand the Food Allergy policy as stated in the LSKC Parent Handbook.
