The Preschool Experience

A preschool child is a very special person who is ready and anxious to learn in a school situation. However, he/she feels deeply about leaving, even for a few hours, the security of his/her home and family. The classroom situation presents many new friends, ideas and ways to learn from both teacher and peers. The gentle blend of home and school lets your preschooler experience a happy and successful year. This in turn prepares the child to encounter, with security and easy communication with others, the school years ahead.

Our purpose at the little school at Kids Cottage is to share love and understanding with young children while helping them advance in their socio-emotional, intellectual, and physical development. We can achieve our goals only if you, as parents and friends, and we as teachers and friends, give our attention and emotion to each child. We look forward to sharing your child and a good friendship with each family.

Developmental and Educational Goals

The curriculum at the little school is designed to reflect the age and interest of the children in the program with special attention given to community events and involvement, multicultural customs and celebrations, and developmentally appropriate skills and topics. The curriculum emphasizes the whole child and includes activities in the following developmental areas: Language, Motor (gross motor and fine motor), Social, Emotional, and Cognitive. The lead teacher in each class will be responsible for implementing a developmentally appropriate curriculum given the age of the children in his/her class.

Community Relations

the little school at Kids Cottage will develop and maintain active relations with local schools and community-based agencies. These relationships will include but not be limited to: communication with local public and private feeder schools, communication with Child Development Watch (birth-3), Early Intervention Services for children ages 3-5, local mental health/behavioral resources, etc.

Student/Family Transitions

The staff at LSKC will support transitions for families into the program, within the program and out of the program. Each transition will be individualized to meet the needs of the child and family. The directors will assist with transition plans and the implementation of activities to promote healthy, positive transitions.

Continuity of Care

LSKC utilizes a system of continuity of care that includes primary care throughout the day to establish an environment in which program staff work together to minimize the number of staff a child interacts with during a day and over time. Primary caregiving ensures consistency of relationships, environment and communication between the staff and the families in order to strengthen relationships and the child's early learning experiences. It also optimizes teachers' knowledge of children's routines, strengths and needs thus helping to create individualized and responsive learning experiences. Whenever possible, long-term staffing assignments will be implemented to ensure consistency across all five days of the week. In addition, LSKC will minimize transition for children throughout the program year.

Registration and Tuition Fees 2020-2021

Registration: There is a fee of \$125.00 to register and enroll your child with the little school at Kids Cottage. This is payable at the time of registration. This fee is nonrefundable and not applicable to tuition.

Withdrawal: A 30 day written notice is required when withdrawing.

Refunds: After the 30 day withdrawal period, any advanced payments will be refunded.

A non-refundable registration fee of \$125.00 is payable at the time of registration and must accompany the application unless the class is full at the time of registration. In addition, the August tuition payment is required as a deposit for new little school at Kids Cottage families. Please note, in order for us to hold a spot for your child for the upcoming 2019- 2020 school year, your child's 2018-2019 tuition must be paid in full by May 10, 2020.

Field Trip/Visitor/Special Event Fees:

Preschool Tuition:

- Pre-Wee (Four Day) – Monday through Thursday - \$4145/year (\$414.50 in 10 monthly payments)
- Wee Little (Four Day) – Monday through Thursday - \$4145/year (\$414.50 in 10 monthly payments)
- Play Little (Four Day) – Monday through Thursday - \$4145/year (\$414.50 in 10 monthly payments)
- Pre-School (Four Day) – Monday through Thursday - \$4145/year (\$414.50 in 10 monthly payments)
- Pre-K (Five Day) – Monday through Friday – \$4640/year (\$464.00 in 10 monthly payments)

Pre-K Enrichment Tuition:

- Five Day – Monday through Friday, 12pm to 3pm - \$3240.00/year (\$324.00 in 10 monthly payments)

Tuition payments are due according to the plan selected on the concurrence form. A late fee of 3% of the total due will be charged to the account if payment is not paid on the due date per the concurrence form. There will be a charge of \$40.00 for any returned checks. Any account sent to collections will incur a 40% interest charge which will be added to your account at the little school at Kids Cottage. As of August 1, 2020, the first month's tuition for all preschool classes will be nonrefundable. A little school at Kids Cottage withdraw form must be submitted 30 days prior to a student's last day if your child will not complete the 2020-2021 school year.

Absences – No refunds or credits will be given due to absences related to vacations and/or illness including Covid-19 related exposure/illness.

SPECIAL EVENTS/FIELD TRIP/VISITOR FEE:

Trips/Special Events/Visitors

At this time, we will have a reduced special events fee of \$75 to be billed in September as we are not permitted to go on field trips or have outside visitors in our building. This fee will include but is not limited to: Pumpkin Patch, Thanksgiving feast, and Holiday Celebration. Should we be permitted to resume field trips and visitors we will resume our regular rate of \$125 in February.

All children attending a 4 or 5 day Preschool/Pre-K program will be billed \$75.00 in September and \$125 in February. The Older Play Little class will incur a fee of \$75.00 due in September and \$75 due in February. These fees cover costs incurred. There is no field trip/special events fee for the Wee Little, Pre-Wee and Younger Play Little classes.

If your child qualifies for the state **Purchase of Care (POC) program**, please inquire at the front desk about our Purchase of Care (POC) plus rates.

Admissions

Admission is on a first come basis with an overall goal of the best possible mix of race, religion, sex, abilities and economic status. LSKC provides the opportunity for diverse learners and their families to fully participate in the learning experience. Families are encouraged to share information about their child such as an IFSP or IEP or a behavioral or health plan. For families who are dual language learners, we will communicate with families using their preferred method to receive information about their children whenever possible. When necessary, adaptations, accommodations and/or individualized plans will be written to ensure the success of all children in the classroom. These adaptations, accommodations, individualized plans may include but are not limited to: changes in the environment, daily schedule, curriculum or teacher-adult interaction.

Please note, LSKC is not a special education facility. Our staff is trained to work with typically developing children. We might help a child who needs a friendly, flexible environment because she/he is above average or needs more time to master skills, but children with significant delays sometimes learn best in special education programs. If we discover during the school year that our program is not the best fit for a particular child, we will ask the parents to explore alternatives with us.

Communication

the little school at Kids Cottage believes that communication between our staff and parents is essential to the ongoing success of the facility, and benefits our children. Parent involvement and suggestions are welcomed. To assure good communication between our staff and parents the following will be used to accomplish this goal:

- Parent Orientation Night
- Daily, individualized communication and monthly calendars will be provided to parents of children between 0-36 months of age.
- Weekly class newsletters and monthly calendars will be provided to parents of children 37 months and older.
- Monthly **school** newsletters and calendars will be sent via constant contact.
- Two parent/teacher conferences will be held per year (one in the fall and one in the spring) to discuss children's progress, strengths and needs. In addition, parents and teachers may request conferences at any time to discuss progress, strengths and needs.
- Brief daily verbal communication between parents and their child's teacher during drop off and pick up times.
- Website (www.thelittleschool.us).
- Parent handbook (online or printed upon request).
- Family Centered Events: When possible, LSKC will organize a variety of family events (i.e., Holiday program, Annual Art Show, Dover Days, Pet Day, Halloween Parade, etc.) some of which will be educational in nature such as parenting education classes and/or information sessions related to curriculum and assessment.
- LSKC will systematically gather information from families and use data to inform program planning annually. This information will be gathered via a parent survey each spring. Feedback will be provided to both staff and parents.

Please be sure to give us your email address for weather cancellations, school updates, newsletters and other important information. In addition, we will send emails and text messages to inform of any weather-related delays and cancellations. Snow Days will be made up during the school year with the exception of "state of emergency" days.

Videotaping/Photography

LSKC website, social media and the local media (i.e. newspapers, TV, etc.) may contain pictures of school activities and events. No names will be used unless parent permission is given. If you do not wish for your child to be photographed for any of these purposes please let us know in the Parent Consent Form.

Family Involvement

We value the importance of a strong relationship between school and home, with that we offer a multitude of family centered events to help build these strong relationships. Throughout the year the families will be invited to but are not limited to parents night, holiday programs, the art show, and Dover Days parade and festivities. We also encourage any family with special talents abilities or cultural beliefs to come and share with the school. Parents are welcome to visit the school at any time.

Covid-19 Policy change – until otherwise noted, in person family involvement will not be possible. Please touch base with your classroom teacher to discuss other possible ways to become involved.

Food Service

Children enrolled in the preschool program will be provided a morning snack time. Children should provide a healthy snack which is packed in a separate bag from the lunch box. Children staying for the lunchtime period are required to provide their own lunch. Lunches should not contain peanut products or any candy items. Please consider all the healthy food groups when packing your child's lunch. Children staying after 3:00pm will be provided another snack time in the afternoon and should pack another healthy snack.

**Transportation
Admission/Release Policy**

The little school at Kids Cottage strives to provide a safe environment for all children. To ensure the safety of your child our school requires that:

- Parents provide the name of the person(s) able to pick up and transport his/her child. All names must be listed on the child's Emergency Card.
- Proper photo identification will be asked for upon the release of a child.
- No child may leave school with anyone other than his/her immediate family unless written parental permission is presented to the teacher/office. This is a very important protective measure.
- Eye contact must be made with the teacher or staff member when dropping off or picking up your child.

If your child is to be released due to health concerns or emergency reasons, and you cannot be reached, other authorized persons on the emergency card will be contacted for immediate pick up. Please make arrangements to have your child picked up from LSKC within 30 minutes of being contacted.

Car pooling: Those parents in car pools need to establish good safety habits with the children involved. Considering younger siblings, **we suggest that there be no more than four (4) school children to a carpool.** This insures proper attention to each child. Be sure that the teacher and the office have the list of persons involved in the carpool. All children are to be brought to their classroom and to be picked up from their classroom at dismissal.

Please use appropriate car seat and seat belts. Never leave children unattended in your car while dropping off or picking up! Please turn off your car before entering the building.

YELLOW CURB: This designated area in the front of the school is to remain open for special conditions. Please do not park in this area.

The Field Trip Experience

Covid-19 Policy change – until further notice field trips and visitors will not occur.

Field trips and visitors are a large part of the little school experience. Different classrooms will experience different trips depending on the age of the children. There are some trips that the children will experience every year; however, the age of the child, teacher, and classmates will change that experience so that it is a new one each time. The other benefit of doing the same trip again is that the children who are experiencing it for the second time gain self-confidence and pride when they can answer correctly the questions being asked by the presenter/teacher.

Our field trip experience goes something like this:

1st year-1st experience: Taking in the new environment, new faces, new ideas, exploring something new for the 1st time, etc.

2nd year—2nd experience: Less nervous about the new experience, environment, familiar faces, similar ideas at an older age level (greater comprehension), joy and excitement in knowing what comes next, predicting and anticipating the answers to question the presenter/teacher may ask, etc.

Chaperones

For each field trip your class teacher will ask for a certain number of chaperones. A sign up will appear outside your classroom door or on the class parent board. We ask that any adult going on the field trip leave your cell phone in the car. We also ask that younger siblings do not attend field trips. Parents who are chaperoning a trip are required to drive separately as there is not always enough room on the school bus for extras. In addition, we require all children ride the school bus with their class to and from all trips.

Just riding the school bus can be a new and exciting adventure. The thrill of traveling with a large group in one vehicle is part of the experience.

Outdoor Climate and Space

Weather permitting we will play outside unless the wind chill factor is 32 degrees or the heat index is 89 degrees or lower and the weather and environmental conditions do not pose a significant health or safety risk. Outdoor playing during these periods outside this temperature range shall be at the discretion of the administration, unless the National Weather Service has issued an advisory regarding health or safety risks for the local area. In the event of inclement weather the children will utilize the indoor playground.

FOOD ALLERGY POLICY

The little school at Kids Cottage (LSKC) strives to create and maintain a healthy and safe environment for all students. There are a number of LSKC students who are severely allergic to nuts and other food items. For some students this is a life threatening situation.

For the reasons above, we are a “nut/allergy aware school.” Please read our policy below and sign and date at the bottom to indicate that you have read and understand the allergy policy. If you have questions, please see Lisa or Shannon in the main office.

- If your child has an allergy that the school needs to be aware of, a written allergy plan should be submitted to the main office **and** your child’s lead teacher prior to the first day of school. This plan must be signed by your child’s physician and then reviewed with the lead teacher.
- Children’s allergy plans will be easily accessible in the classroom for all those who come in contact with the child.
- Parents of children with allergies should provide any necessary medications in case of a reaction (Benadryl, epi-pens, etc). These medications **must** be left in the main office and a medication log **must** be completed.
- Additionally, we ask that you provide the snacks and treats for your child if he/she has an identified severe food allergy.
- We ask **all** parents to prepare lunches and snacks from foods that do not contain nuts.
- LSKC promotes the policy of “nut free” foods and materials used in the classroom. However, due to changing labels we cannot guarantee the food we provide is not manufactured in a factory that may contain nuts.
- LSKC cannot guarantee that others outside of our control (i.e., parents, grandparents, babysitters, caregivers, etc.) will abide by our food allergy policy when preparing foods for their children and/or when providing food for the classroom.

A healthy snack time will be provided in the morning and afternoon. All snacks should be sent from home.

Child Abuse and Neglect

Each staff member at the little school at Kids Cottage will be given written information governing the reporting provision of the Delaware child abuse and neglect law(s) and regulations, center policies and procedures for reporting and documenting suspected abuse and neglect and maintain on file written documentation of their receipt of this information.

The little school at Kids Cottage directors will not discourage, inhibit, penalize or otherwise impede any staff member from reporting any suspected or alleged incident of child abuse or neglect.

In the case of child abuse or neglect that occurs at the little school at Kids Cottage, staff will follow the policies and procedures outlined below:

Suspected abuse or neglect will immediately be reported to the directors who will report the incident as required by Law.

Any staff member alleged to have perpetrated an incident of child abuse or neglect shall not have direct contact with any child and will be reassigned to other duties that do not involve contact with children until the investigation of the incident has been completed.

Health/Sanitation

Health Habits: Staff and children will practice healthy habits by washing their hands with soap and running water a various times throughout the day. These times will include but not limited too before and after eating and after toileting or diapering.

Regular rest, good nutrition, healthy eating habits and a good morning start has a dramatic effect on your child's interest level and performance.

Covid-19 Policy Change

As of March 16, 2020 we are following all guidelines for childcare/preschool centers as set forth by Governor Carney, the Department of Health and the Department of Childcare Licensing for COVID-19.

The procedures in our facility include, but are not limited to:

*All parents are asked to stand where marked outside while waiting to drop-off and pick-up their children. The designated areas are marked off by painted signs and are at least six-feet apart. We have asked that parents allow extra time when dropping off in the morning.

*All parents/guardians are met at the door for drop-off and pick-up. No outside visitors are allowed in the facility at this time, except for therapists for students in need.

*All staff/children will have their temperature checked at the door and will be asked the necessary questions to determine if they meet the criteria set by the state to be allowed entry. If a staff member or child presents with any symptoms indicating potential COVID-19, they are not allowed to enter the building or return until cleared by a physician.

*All staff/children must sanitize their shoes before entry into the building. This will be done by the parents prior to bringing the children to school or at the front door.

*All staff/children must wash their hands upon entry.

*Staff and children must continue to wash hands frequently throughout the day.

*Adults will wear masks whenever social distancing cannot be maintained.

*Visiting therapists will wear masks at all times when in the building and follow all of the above listed health precautions.

*All equipment is cleaned before and after use, as well as throughout the day.

*All toys are cleaned before and after use, as well as throughout the day.

*All tables and shelves are wiped down before and after use, as well as throughout the day.

*Classrooms are sanitized each day.

Sick Policy

After an elevated temperature of 100+ or above, a child may not return to school until a normal temperature has been held for forty-eight (48) hours without the aid of medication.

Communicable Diseases: Please notify the school if your child is absent because of a contagious disease. We can inform you concerning the required isolation periods and thus protect the other children.

Please do not send your child if she/he shows any of the following symptoms. If your child exhibits any of the following symptoms he/she may not return to school for forty-eight hours(48) without the aid of medications.

1. Sign of abnormal temperature
2. Nausea, vomiting or diarrhea
3. Any other signs of illness, e.g. swollen glands, skin rashes etc.

Covid-19 Policy Change – If a household family member, including the child, has been exposed or is ill due to covid-19 please see Lisa or Shannon regarding DPH and Office of Childcare current guidelines.

Medication

Medication can only be given by staff members authorized in accordance with State Law and cannot be administered to a child without written permission from the child's parent. **All medication shall be in its original container, properly labeled, and authorized by the child's health care provider. All medications will be stored where they are inaccessible to children.**

Accident/Emergency

In the event of an accident, an Injury Report will be completed and signed by a staff member and filed. In case of an emergency, the center will call 911 and contact the parent/guardian. Information from the child's records will be used to obtain necessary emergency information. The little school at Kids Cottage will document all information

pertinent to the emergency and a copy will be sent home and kept on file in the main office.

Positive Behavior Management

One of **our** goals is to develop a positive self-esteem in each child. The staff will use positive developmentally appropriate methods of behavior management to redirect a child when necessary. As a policy, we will intervene, redirect the behavior, and praise the new positive behavior. If it is a recurring behavior, we will counsel with the parent(s) and set up a behavior plan.

If at anytime you are not satisfied with your experience at the little school please bring it to the attention of the administrators.

A copy of the DELACARE handbook can be found in the office at all times for families to review.

Curriculum

Creative Curriculum

Now, in its latest edition, *The Creative Curriculum® for Preschool* is everything that teachers love: a comprehensive, research-based curriculum that features exploration and discovery as a way of learning. The Creative Curriculum for Preschool is based on five fundamental principles: Positive interactions and relationships with adults provide a critical foundation for successful learning.

Social-emotional competence is a significant factor in school success.

Constructive, purposeful play supports essential learning.

The physical environment affects the type and quality of learning interactions.

Teacher-family partnerships promote development and learning.

Handwriting Without Tears

The Handwriting Without Tears curriculum prepares young learners for school using three programs: Readiness and Writing, Language and Literacy, and Numbers and Math. These programs complement and expand our existing Preschool and Pre-K programs.

STEAM (Science/Technology/Engineering/Art/Math)

STEAM a curriculum based on the idea of educating students in four specific disciplines — science, technology, engineering and mathematics — in an interdisciplinary and applied approach. Rather than teach the four disciplines as separate and discrete subjects, STEAM integrates them into a cohesive learning paradigm based on real-world.

Phonics

We use the Phono-visual* method. It is primarily designed to help children distinguish initial consonant sounds. "This is not a method of teaching reading by itself. It is not presented as a substitute, nor does it presuppose the discarding of all sight reading. It is to be used as a

supplemental tool, as parallel teaching in a developmental reading program.” At this level it is a readiness tool .

*Phono-visual Products, Inc.

In addition to the phonics program, the little school at Kids Cottage classrooms are reading oriented. The children engage in a program that prepares them for reading as their teachers read to them from a book. They will see words on the chalkboard, they will browse at the library books, they will dictate their experiences to the teacher who prints them on large chart paper and later reads them to the children. This language and/or learning experience approach (LEA) is often implemented in the classroom, along with inventive spelling (creative writing). Such a program develops an eagerness to learn to read on the part of the children when they reach developmental readiness.

Music

The music program at the little school at Kids Cottage provides a “fun time” for the children to use their imagination while singing, dancing and playing musical games. The children gain an understanding and appreciation of music by learning high and low, loud and soft, fast and slow, etc. Rhythms are strongly emphasized throughout the school year. Preschoolers experiment with percussion and woodwind instruments. Music programs are prepared and enjoyed at the holiday time and in May at Dover Days.

Communication

Teaching students to speak easily, freely and clearly is one of the most important phases in the language development of the children. This can be done by encouraging them to share their experiences (i.e. trips, pets, toys, etc.), by relating stories to the class, by conversations with the teachers and peers during classroom and play periods, and by acting out stories, which have been read to them. All of these activities will help children develop a background of useful knowledge.

Attendance

An effective program requires that your child arrive on time each day. Regular attendance is necessary for the child to gain the greatest benefit from the program. **It is extremely important that your child arrives to school in time for his/her preschool class.**

ASSESSMENT

Developmental Screening Tool: Ages and Stages

LSKC will implement a child developmental screening (Ages and Stages) for all students on an annual basis. Children exhibiting developmental delays in any area will be discussed with the co-directors and if warranted, appropriate referrals will be discussed with parents. The co-directors will help guide/support children and their families through the referral process if needed.

Assessment Tool: Teaching Strategies Gold

In recent years, research has offered new insight into the importance of early learning and its relationship to school and success in later life. Much of this evidence links children's early cognitive, language and social-emotional development to later developmental and school outcomes (Hair, Halle, Terry-Humen, Lavelle & Calkins, 2006). In response to this research, the little school began using the Teaching Strategies Gold Assessment System (TSG) in the fall of 2015. This observation-based assessment system for children from birth through third grade is a resource that supports effective teaching and the natural development of children. TSG is an authentic ongoing assessment tool designed for use as part of your child's everyday learning experiences.

Afternoon Little (Extended Care/EC)

Afternoon little is a service offered both before and after school hours to children who are enrolled in a little school at Kids Cottage Preschool or Pre-K class. The Afternoon Little program is a planned program that enhances the curriculum from the school day in a less structured environment. It includes a time for lunch, rest, stories, afternoon snack, crafts, cooking, outdoor play and indoor free play. This service is also available to school aged siblings before and after their school day. Ask about our After School Club for school age children.

Camp Little/School-Age Camp

During the summer months we have a day camp at the little school at Kids Cottage. This program offers outdoor experiences, visitors, water play, crafts, music, games, etc. All of our camps run in weekly sessions from mid-June through mid-August. Children may attend half day (9:30 a.m. - 1:00 p.m.) or full day for one or more sessions depending on the child's interests and the needs of the family. OTHER HAPPENINGS

After School Club

The little school at Kids Cottage offers an After School Club for children ages 5-12. The program provides snack, homework help and indoor and outdoor free play. Transportation will be provided by Capital School District for children attending Booker T. Washington, North Dover, Fairview, William Henry Middle School and Central Middle School. Upon request, the area private and charter schools will also drop off and pick up at the little school. These schools include St. Anne's, Holy Cross, Academy of Dover, Campus Community and Providence Creek. A non-refundable \$50 registration fee is required per child to enroll in this program. Hourly rates apply. For more information please contact the little school at 734-3040.

Drop-In Childcare

The little school at Kids Cottage offers a drop-in childcare program for children ages 2-12. Children may be dropped off at the parent's convenience for an hourly fee. Qualified staff are available to monitor and play with the children. The center offers a multipurpose room filled with indoor play equipment.
